FAQs

What are the benefits of becoming registered and having the RCM© Designation? (letters after your name)

The designation is only available to Myomassologists who have graduated from an institution in Canada that is recognised by the Canadian Examining Board of Myomassology Practitioners. This ensures to the Canadian public that you are recognised by a board of your peers in this profession.

Is this designation recognised across all regions and provinces in Canada?

Yes. The Canadian Examining Board of Myomassology Practitioners is incorporated by federal charter in Canada.

Is the RCM© designation a protected term?

Yes. RCM© is protected by Copyright Law through the Canadian Intellectual Property Office in Ottawa, Canada (CIPO) under Registration Number 1209771. Nobody, other than those persons who are registered with the Canadian Examining Board of Myomassology Practitioners is entitled to use this protected term.

Where does my money (\$500.00 fee) go and what is it used for?

Your \$500.00 fee goes to support the Myomassology profession in Canada through the Canadian Examining Board of Myomassology Practitioners, which is a Canadian non profit corporation. Programs to educate Canadians about the health benefits of Myomassology will be funded through a Canadian Myomassology Association.

A Canadian Myomassology Association?

Yes. The Canadian Examining Board of Myomassology Practitioners is mandated to support the founding of a Canadian Myomassology Association. The Myomassology profession grew, first of all, from within the American Massage Therapy Association in the US as a result of a decision made by the association at their Annual AMTA Conference in Hot Springs, Arkansas in 1972. Massage Therapy Associations in Canada never chose to adopt the holistic philosophy of Myomassology and because of this the Myomassology profession in Canada never had an association of their own. Until now, that is.

What are the benefits of having a Canadian Myomassology Association?

Myomassologists in Canada will have their own association with their own Codes of Conduct and Codes of Ethics. This will ensure professionalism in the profession across all provinces, territories and regions in Canada. The association will support Myomassologists in Canada with quarterly newsletters from Myomassologists, for Myomassologists, shared by Myomassologists. Annual Conferences and Educational Workshops, created by Myomassologist, for Myomassologists will also showcase interesting speakers with topical views to share and discuss. A Canadian Myomassology Association will also elevate the Practice of Myomassology in Canada, not only within the Canadian public but also within other Bodywork Professions in Canada.
